<Application Qualifications>

Applicants should:

- 1. NOT have Chinese nationality; Hold a valid ordinary passport;
- 2. Be physically and mentally healthy; Not have criminal record;
- 3. Have acquired a bachelor degree or above;
- 4. Have a good command of English: the overall score of IELTS must be 6.0 or above, or TOEFL score must be 90 or above. Applicants who have obtained an English-taught degree should provide a certificate of language instruction issued by their previous universities. Applicants who are native English speakers are not required to submit English proficiency certificate.
- 5. Be subject to the additional nationality regulations of Ministry of Education of People's Republic of China.

<Tuition>

The tuition for the International Master of Public Administration and Policy Program is RMB 60,000 per academic year for the regular study period of two years.

According to the university charter, our institution operates across the Zhongguancun Campus and the Tongzhou Campus.



<Core Courses with Credits>

All students are required to complete a minimum 34 credit hours of course work and a thesis to obtain the degree in about two years' time.

Courses and Degree requirements

The courses consist of prerequisites, required cores and free electives. Students need to complete all the prerequisites, cores and selected electives. Each course counts 2 credit hours except Academic Standards and Thesis Writing with 1 credit hour, Contemporary China's Politics with 3 credit hours and Chinese Language with 4 credit hours.

<Scholarships>

1. Chinese Government Scholarship Type A: Bilateral Program

The applicant should first apply to the dispatching authorities for overseas study of your home country, such as Chinese embassies and consulates abroad or other organizations. Applicant should log in to the Chinese Government

Scholarship Information System (https://studyinchina.csc.edu.cn), and fill out the application form and choose Type A. The first choice of the university should be Renmin University of China.

The dispatching authorities will send the application information to the university to decide whether the application can be approved by qualification and interview.

2. Chinese Government Scholarship Type B: High-level Program and Silk Road Program

The applicant should apply to the university and the Chinese Scholarship Council at the same time while applying for the master program. Applicant should log in the Chinese Government Scholarship Information System (https://studyinchina.csc.edu.cn) and fill out the application form by choosing Type B, High-level Program or Silk Road Program. Agency number of Renmin University of China is 10002. The final list will be issued by the China Scholarship Council.

The application period and enrollment guide will be further notified.

3. Beijing Municipal Government Scholarship

The scholarship will provide tuition reduction to the students for the first academic year accordingly. The full scholarship is the reduction of 30000 yuan, half scholarship is the reduction of 15000 yuan. If the basic tuition is lower than the amount of the reduction, the reduction will considered the factual situation. The application requirements and procedure will be further notified.
