* The tuition fees for Master's program (English-taught) shall be subject to the announcements in the admission brochures of each program in the current year.

II. Tuition Payment within the Normal Study Period

1. **The tuition fee standards for international students are calculated on an academic-year basis.** Degree-seeking students shall pay the full tuition fee for one academic year at the time of registration according to the tuition fee standards. Non-degree-seeking students shall pay the full tuition fee for one semester (half an academic year) or one academic year according to their study duration. If the study duration exceeds one semester but is less than one academic year, the tuition fee shall be paid according to the one - academic-year standard. If the study duration is one semester or less, the tuition fee shall be paid according to the one-semester standard.
2. International students should pay the full tuition fee on time within the time specified by the university. **Freshmen admitted in the current year** must pay the full tuition fee for one year in a lump sum **at the time of registration**. **Current international students** should pay the tuition fee for the next academic year (or the next semester) **before the end of the registration period of the current year**. Only after paying the tuition fee can they apply for procedures such as visa extension in China for the next academic year.
3. International students who truly have special circumstances and cannot pay the tuition fee on time should submit the “*Application for Deferred Tuition Payment Form*” to their school before September 15th of each year. The school will report it to the International Students Office for review and approval. After approval, **students should complete the tuition payment before the deadline specified in the application form (usually November 30th of each year)**. Students applying for deferred tuition payment should meet the following conditions:
 - (1) Have valid enrollment status and registered.
 - (2) Have financial hardship.
 - (3) Have technical payment issues.
 - (4) Waiting for the CSC scholarship extension application.(Condition 1 is mandatory; at least one of 2-4 must apply)
4. **For international students who owe tuition fees without justifiable reasons, their student status will not be registered during the period of arrears, all functions of their campus cards will be suspended, and they will not be eligible to participate in the evaluation of various scholarships, etc.**

** Applies to graduate students delayed due to publication requirements, thesis revisions, or defense failure.

IV. Refund Policy

1. International students who are approved for suspension of study do not need to pay tuition fees during the suspension period. For those who have already paid the tuition fees and apply for suspension of study during the academic year and are approved by the university, the paid tuition fees can be carried forward for use after resuming study.
2. For students who are approved to withdraw from university or have their student status cancelled, the actual study period shall be determined based on the time when they complete the withdrawal procedures. After providing the payment receipts as required by the university, they can apply for a tuition refund according to the following standards:

Withdrawal Timing	Refund Rate
Before semester registration*	100%
Within 10 days of semester start	80%
Within 30 days of semester start	50%
After 30 days of semester start	No Refund

* The start date of the semester generally refers to the Monday of the first week of each semester on the academic calendar.
